Dear Parent/Carer,

It looks like this half term is going to be as strange as the last one with the current national lockdown. I hope your son managed to get some rest at half term so that he feels ready and energised for what is to come. Like all schools, we are facing staffing issues, have a number of students self-isolating and are trying to manage students in class and out of class at the same time. Whilst this is exhausting, we still believe schools are the best places for young people to be for their welfare as well as their education. It is difficult to predict the national situation going forwards so I would emphasise that each week schools are able to be open is a really great opportunity for our young people.

The Department for Education issued guidance on what the new national restrictions mean for education and childcare settings on Wednesday afternoon. The guidance gives leeway for settings to make these changes **by Monday 9th November**. Here is a summary which I hope you will find helpful.

# Summary

# Face coverings

- Face coverings will be mandatory in communal areas of secondary schools. They are still not
  recommended in classrooms. At The John Fisher School, students are not expected to wear a face mask
  in lessons unless the professionals are unable to maintain a 2m distance, have any concerns about
  ventilation, are teaching a combination of Year 12 & Year 13 students or have Year 12 & Year 13
  students sharing the same learning space.
- Face coverings will be mandatory for students in Year 7 and over on dedicated school transport.
- Students are permitted to wear surgical masks. We have asked students not to wear any masks which could cause any offence/distract others in their learning.

# Curricular, extra-curricular activities, examinations and 16-19 programmes

- PE, sport, music, dance and drama lessons can continue in line with the current guidance during school time.
- Schools must only provide team sports listed on the <u>return to recreational team sport framework</u>. Competition between different schools should not take place.
- Schools are able to work with external coaches, clubs and organisations for curricular activities where they are satisfied that it is safe to do so.
- After-school clubs can only continue if their primary purpose is childcare. So wraparound care in a primary school would be fine, but a Year 8 after-school rugby session would not.
- The current series of examination resits should continue.
- For 16 to 19 study programmes, providers should continue to seek to deliver the majority of education on site unless they have had written public health advice to move some groups to remote teaching.

## Feedback on Relationships, Sex and Health Education (RSHE)

We have a parent forum taking place this Saturday on 'learning platforms' and the focus of the parent forum on Saturday 28<sup>th</sup> November will be 'Relationships, Sex and Health Education' (RSHE). We will continue to be reinforcing to students, particularly those in Key Stage 4, about the importance of healthy relationships, consent, the law, the teachings of the Catholic Church etc.
